

Goal of the course:

Housing estates represent specific parts of cities of Visegrad region, which undoubtedly require coherent approach regarding urban planning and municipal management. Their spatial structure with oversized public spaces lacks in economical as well as environmental sustainability. Because of the general public perception they are in a strong risk of social decline. However, in Visegrad context we have until now mostly dealt only with technical standard of the prefab houses themselves and have often overlooked the complex problems of the areas. The aim of the course is to analyse current situation of housing estates and discuss the possibilities of how to proceed with their transformation into successful neighbourhoods and how to minimize the danger of social problems.

Target groups:

The course is focused on V4 students of architecture (master program, students with basic urban design experience). The workshop is open for 10 students from Hungary and 10 students from Czech Republic.

The result of the course is supposed to have an impact not only on students but also on general professional community and decision makers within the region.

Concept of the course:

The course consists of the workshops and additional lectures. It follows after previous year of the course which took place in The Czech republic.

The main objectives of the workshop is reviewing the situation of housing estates in chosen V4 localities and propose the potential solutions of their specific problems. The purpose of Visegrad cooperation on this project is to unify representatives of academic and the state sector in V4 region, which is considered to be one of the most affected in Europe concerning at this issue.

The aim of the lectures:

To bring experience from different countries – problems identification, approaches, solutions, to explain specific housing estate issues.

The aim of the workshop:

Within the workshop some problematic localities will be selected and analysed as case studies and design strategies will be proposed.

Content of the workshop:

During the workshop, basic conceptual frames and theoretical approaches associated with sustainability of housing estate will be analysed. A part of the workshop will be a discussion on proposals of possible ways of housing transformation solutions.
